- Students should apply to the **UM at the beginning of their second-to-last semester** at ICM, prior to completing 30 unique credit hours:
- To complete ICM 30 unique credit hours with Best Ten GPA 2.0 is required (does not include failed/repeated courses).
- UM Admission GPA required: Minimum 2.0 AGPA\* to be eligible.

- CGPA includes all failed and/or repeated course
- Intakes are available in Fall and Winter Terms. Admission to the Winter term is on a space available basis only.
- Students must complete a minimum of 24 credit hours by the end of April, with 30 unique credit hours completed by the end of August of the application year. Students who need to complete courses during the Summer Session for the Fall intake and Fall Term for Winter intake to meet the minimum credit hour requirement will only be considered for admission on a space available basis after all other eligible students have been considered.
- If the number of eligible candidates exceeds the available spaces, an adjusted grade point average higher than the minimum may be required for admission.
